A regular meeting of the State Water Conservation Commission was held in the meeting room of the Chamber of Commerce offices at Minot, North Dakota, on September 2, 1949.

The meeting was called to order by the Chairman, Governor Fred G. Aandahl, at 9:30 o'clock a.m., with Commissioners Thompson, Einar Dahl, Olson, Math Dahl, Christensen, Secretary J. J. Walsh and Governor Fred G. Aandahl present. Also present at the meeting were those mentioned above.

It was moved and seconded by the Members of the Commission that the Minutes of the June 25, 1949 meeting of the Commission stand approved as read. Motion carried.

A motion was made by Commissioner Einar Dahl that the Financial Statements for the months of June and July, 1949, be approved. The motion was seconded by Commissioner Thompson. Motion carried.

Contract 179r-201 with the Bureau of Reclamation was brought to the attention of the Commissioners. The expiration date of this contract is December 31, 1949, and payments on this contract have heretofore been made from the appropriations fund for the 1945-1947 biennium, which fund reverted to the State Treasurer on June 30, 1949. The question was whether the unobligated balance of the 1947-49 appropriations fund, in the amount of \$10,791.56, could be allocated to the Bureau of Reclamation to cover expenditures on Contract 179r-201 until the expiration date.

The Commission authorized the Secretary to make application to the Special Board provided under Chapter 54-2709, for the unexpended balance due the Bureau of Reclamation on Contract 179r-201.

Among the business to be considered were meetings scheduled for the coming months. Governor Aandahl recommended that Commissioner Einar Dahl attend the organization meeting of the State and Federal agencies interested in the Missouri Basin development, known as the North Dakota Natural Resources Council, to be held at the North Dakota Agricultural College at Fargo on September 12. Commissioner Dahl will officially represent the Water Commission at future meetings, and other members will attend whenever convenient.

Secretary Walsh was instructed to write to Mr. Fred J. Fredrickson of Valley City, notifying him that the Members of the Water Commission would like to have him attend the National Water Conservation Conference, to be held at Chicago on September 22 and 23.

Commissioner A. M. Christensen and Secretary Walsh were delegated by the Commission to attend the Public Hearing on the Investigation for Flood Control on the Souris (Mouse) River, North Dakota, to be held in the District Court Room of the Ward County Court House, Minot, North Dakota, on September 28, 1949, at 10 o'clock a.m.

It was the recommendation of the Commission that they hold a regular meeting in Devils Lake on November 18 and 19, at the time the North Dakota Reclamation Association will be holding its annual convention there.

A voucher, in the amount of \$400, from the National Reclamation Association for annual membership in the Association was considered by the Commission and the following action taken: Commissioner Einar Dahl made a motion that the State Water Conservation Commission approve the payment of \$400 for annual membership in the National Reclamation Association for the year 1949. The motion was seconded by Commissioner Olson. Upon call of the roll by the Chairman, Commissioners Math Dahl, Einar Dahl, Olson, Thompson, Christensen and Governor Aandahl all voted aye. Motion carried.

The Commissioners discussed the flowage easements required by the U. S. Corps of Army Engineers in connection with the construction of the Baldhill Dam and Reservoir. Governor Aandahl explained to those present that flowage easements had been given by the townships involved, and that the State Highway Department had worked out a system of secondary roads whereby the townships would receive Federal aid in relocating highways and bridges in the Baldhill Reservoir area. He stated that the Eastern North Dakota Water Development Ass'n has also assisted with a cash contribution to replenish federal funds. An opinion from the Attorney General's office stated that "township boards, as political subdivisions of the state, had legal authority and were discharging a governmental function when executing the flowage easements required by the War Department of the United States".

With reference to a letter received from Homer W. Ludwick, Executive Vice President of the Eastern North Dakota Water Development Association, requesting that applications for rights to the use of water from the Baldhill Reservoir be given consideration at some future meeting, the Commission were of the opinion that this meeting should be held in Bismarck, at the call of the Chairman. The Commission believed it advisable that the Eastern North Dakota Water Development Association first contact the Attorney General's office and also the Corps of Engineers at St. Paul in order to have some understanding in regard to this matter, before the meeting is called. The Secretary was instructed to write Mr. Ludwick to that effect, and inform him of the coming meeting.

A Resolution adopted by the Cass County Commissioners, the Cass County Drainage Board and the City of Fargo, and approved at the last meeting of the State Water Conservation Commission, regarding the allocation of monies by the Commission for the purpose of constructing a drain for the drainage and diversion of waters from the Sheyenne River into the Red River was further discussed by the Commission. Secretary Walsh was instructed by the Commission to write letters to those concerned, notifying them that the

Commission would match money up to 40% of the cost for drainage of agricultural land, and funds for matching on a 40% basis will be made available not to exceed \$20,000 for this work, and that surveys and plans for the drainage ditch are to be approved by the engineers of the Soil Conservation Service and the State Water Conservation Commission.

Harry E. Polk, President of the National Reclamation Association, explained to the Commission why the people of Williston are supporting the 1830 foot level. He informed the Commission that if they could come to some mutual agreement on a plan of protection that would satisfy the people of Williston, their community would be most happy about it.

The following applications for permit to divert and appropriate water of the State of North Dakota were acted upon by the Commission at this time:

Commissioner Thompson made a motion that the application of Howard Peterson, Pekin, North Dakota, for a permit to divert and appropriate water from the Sheyenne River, tributary of the Red River, for irrigation purposes, having been published in the "Lakota American" for four consecutive weeks, and the necessary papers and maps filed with the State Engineer, be approved subject to prior and existing water rights covering the Sheyenne River. The motion was seconded by Commissioner Olson. Upon call of the roll by the Chairman, Commissioners Math Dahl, Thompson, Christensen, Olson, Einar Dahl and Governor Aandahl all voted aye. Motion carried.

Commissioner Einar Dahl made a motion that the application of Loyd Stevens, Watford City, North Dakota, for a permit to divert and appropriate water from the Little Missouri River, tributary of the Missouri River, for irrigation purposes, having been published in the "McKenzie County Farmer" for four consecutive weeks, and the necessary papers filed with the State Engineer, be approved subject to prior and existing water rights covering the Little Missouri River. The motion was seconded by Commissioner Christensen. Upon call of the roll by the Chairman, Commissioners Einar Dahl, Christensen, Olson, Math Dahl, Thompson and Governor Aandahl all voted aye. Motion carried.

The Secretary informed the Commission that Mr. V. L. Gilbreath has applied to the Water Commission for assistance in making surveys on his project and pay part of the cost. It was proposed by Commissioner Einar Dahl that the State Water Commission aid in surveying small individual irrigation projects on a fifty-fifty basis, the individual paying 50% of the cost of the surveys and the Water Commission the remaining 50% of the cost. The Commission decided to make this a general rule.

Commissioner Olson made the following motion: "I move that the State Water Conservation Commission authorize the Secretary and Chief Engineer to pay 50% of the survey cost of making surveys on small individual irrigation projects, privately owned and operated." The motion was seconded by Commissioner Einar Dahl. Roll was called by the Chairman, Governor Aandahl, with Commissioners Thompson, Einar Dahl, Olson, Math Dahl, Christensen and Governor Aandahl all voting aye. Motion carried.

Mr. J. H. Svore, Sanitary Engineering Director of the State Health Department, Bismarck, appeared before the Commission recommending they pass a resolution endorsing certain pollution standards for control of industrial wastes in the Red River, as recommended by the Interstate Sanitation Committee. This Committee is comprised of members of the Health Departments of North Dakota, South Dakota and Minnesota, and also conservationists of those states, and was organized in 1944. Mr. Svore read the following "Resolution" to the members of the State Water Commission:

Standards of Treatment for Municipal and Industrial Wastes
for the Red River of the North

The following previously adopted standards on stream pollution control are hereby confirmed and clarified, and recommended for use under ordinary conditions as a basis

for the review of plans prepared and submitted to the regulatory agencies of the respective states for sewage and waste treatment facilities discharging into the Red River of the North and the tributaries as they affect the Red River of the North.

It is recommended that industry and municipalities treat their wastes to the point where the average daily composite 20°C., 5-day B.O.D., is 25 P.P.M., suspended solids 30 P.P.M., with no peaks running over 50 P.P.M., 20°C., 5-day B.O.D. and 60 P.P.M. suspended solids. Chlorination shall not be used as a means of obtaining these B.O.D. reductions, although it may be required for other purposes. Certain types of industrial wastes such as those resulting from the processing of agricultural products, may have to be considered on an entirely different basis.

It is further recommended that these standards be considered as general only, and that they be subject to modification to meet specific pollutional problems as they develop.

Commissioner Olson made a motion that the Resolution adopting "Standards of Treatment for Municipal and Industrial Wastes for the Red River of the North" be adopted by the State Water Conservation Commission. The motion was seconded by Commissioner Thompson. Upon call of the roll all members voted aye. Motion carried.

The Board of County Commissioners, Bowman County, submitted resolutions requesting the organization of a Bowman County water conservation district. Commissioner Math Dahl made the following motion: "I move that the State Water Conservation Commission proceed with the organization and establishment of a water conservation and flood control district, to be known as the Bowman County Water Conservation and Flood Control District, consisting of all the territory contained within the boundaries of Bowman County, North Dakota". The motion was seconded by Commissioner Einar Dahl. Motion carried.

Mr. M. M. Millhouse of Williston was present at the meeting to seek assistance in the building of a dam to create a small lake to provide for recreational facilities. Mr. Millhouse was advised to keep in touch with the Commission, as there might be a possibility of working out a cooperative arrangement for assistance.

A report submitted by the State Game and Fish Department on the Lake Juanita project was presented to the Commissioners. This report stated that a survey had been made to determine the fish values of Lake Juanita, and the lake had been found to be too shallow to sustain fish life through the winter, and the expense of keeping it re-stocked with desirable fish would be too great. The Commission concluded this was not a desirable project and requested Secretary Walsh to write Mr. E. R. Bradley, Secretary of the James River Valley Improvement Association to that effect, sending him a copy of the report submitted by the State Game and Fish Department.

Secretary Walsh submitted to the Commissioners a report on the survey of the Golden Lake Restoration, Steele County, made by Engineer Duane Torvik of the State Water Commission. This project is estimated to cost \$20,000. The development of this project consists of restoring Golden Lake and a neighboring lake to their former levels by refilling the lakes. It will be necessary to construct a diversion dam and ditch. It was decided to leave further action on this project to Mr. H. R. Morgan of the State Game and Fish Department, as the Northwood Sportsmen's Club sponsoring the project is interested in making it a wildlife preserve.

Correspondence from H. R. Morgan of the State Game and Fish Department was read in which Mr. Morgan agreed to participate in the repair of Sykeston Dam in an amount not to exceed \$2,000. As the purpose of this dam is for municipal water supply, it was suggested that the Commission pay 50% of the total cost of \$12,000, if the local agencies will share in one-third of the cost.

A motion was made by Commissioner Christensen that the State Water Conservation Commission contribute one-half of the total cost of the repair of Sykeston Dam, in the amount of \$6,000, providing the State Game and Fish Department participate in the amount of \$2,000, and local interests pay one-third of the total cost, in the amount of \$4,000. The motion was seconded by Commissioner Math Dahl. Roll was called by the Chairman, Governor Aandahl, with Commissioners Math Dahl, Einar Dahl, Governor Aandahl, Thompson, Olson and Christensen all voting aye. Motion carried.

The Lake Metigoashe outlet dam was under discussion, the structure requiring repairs: The Commission is willing to assist the County, providing they replace the present pipe culverts with a bridge of sufficient opening to allow flood water from the lake unrestricted discharge.

A letter was read by Governor Aandahl from D. W. Gordon, Secretary of the Commercial Club, Regent, North Dakota, in which they requested information on whether their lake at Regent, known as Larson Lake, could be set aside as a State Park or recreational center sometime in the future. The Commission decided this was a matter to be referred to Mr. Russell Reid of the State Historical Society.

Secretary Walsh informed the Commissioners that he had contacted Colonel Seybold of the U.S. Army Engineers at Fort Lincoln regarding storage space for Water Commission machinery and equipment. They were quite sure two buildings at Fort Lincoln could be assigned for this purpose.

Governor Aandahl read a letter from Theo. W. Sette, Manager, Credits Department, Bank of North Dakota with reference to interest and bonds of the Sioux Irrigation District. Commissioner Einar Dahl informed the Commission that Judge Christensen and he were taking care of the details as to refinancing of the Sioux Irrigation District bonds, and they would have their recommendations ready for the Commission at a later meeting.

The members of the Commission were notified of the reappointment of Earle F. Tucker to the State Water Conservation Commission, by Governor Aandahl, for a term of six years, the term to run from July 8, 1949 to July 1, 1955.

Russ Dushinske from Devils Lake reported on underground water surveys in the Devils Lake vicinity, stating that test drilling has been done both near Sweetwater Lake and on Grahams Island, where a water supply of about one-half of the needs of the City of Devils Lake had been found. The U. S. Geological Survey agreed to move back to Sweetwater Lake and make further tests near the Great Northern railroad wells.

The Commission approved a voucher from the Greater North Dakota Association in payment of a moving picture historical record of water development, in the amount of \$498.96, being made by W. P. Sebans for the State Water Commission.

Governor Aandahl reviewed the Yellowstone Compact with the members of the Commission. He explained that prior to 1945, the Yellowstone Compact was approved by North Dakota and Montana, but was vetoed by the Governor of Wyoming. He had recently received a letter from Governor Bonner of Montana requesting his opinion on a convenient time to hold a meeting. The Commission agreed that North Dakota should send representatives to attend.

Governor Aandahl read a letter he had received from A. J. Dexter, Agricultural Agent for the Northern Pacific Railway, in which he urged immediate action on the development of the Fort Clark project. Governor Aandahl informed the Commissioners that he had taken up this matter with Kenneth Markwell, Kenneth Vernon, and Bruce Johnson, all of the Bureau of Reclamation, and they were of the opinion that further action would have to come from the Washington office, and that Kenneth Markwell would check on this project upon his return to Washington. The Heart River project was also discussed. The repayment contract will have to be approved by land owners in the irrigation district, and

The Governor stated he would call R. E. Sylvester, Chairman of the Board of Directors, and suggest they meet with the Commission regarding this project, a meeting to be called the latter part of the month or the first of October.

It was suggested that a meeting with the Eastern North Dakota Water Development Association be called for the same date, to discuss water right priorities in connection with the Baldhill Reservoir.

Harry E. Polk, Williston, President of the National Reclamation Association, extended an invitation to the entire Commission to attend the annual convention of the National Reclamation Association, as official delegates, at Salt Lake City, Utah on November 2, 3, and 4.

As there was no further business before the Commission, the meeting adjourned at 1:10 p.m.
